Ansin recently founded FatherForm - an Al-powered family connection platform that helps new and expectant fathers strengthen relationships through interactive network visualizations, personalized timeline insights, video journaling, gift tracking, and smart reminders—all designed to proactively support their journey into fatherhood.

In addition, Ansin is an advisor and investor in multiple waste-to-value businesses surrounding surplus produce including Sierra Agra, Midnight Venture Partners, and others. He also supports The Footwear Collective, an effort out of MIT to discover global recycling solutions for footwear; The Network, creating actionable intelligence to defeat human trafficking; and until recently was head of the grant committee at GK Fund.

Prior to his current focus on waste to value, Ansin began retrofitting abandoned mill buildings in 2015 to bring scaled indoor-agricultural into the cannabis industry while aimed at revitalizing strained, postindustrial-era cities across the country. He invested across the industry, deploying and advising on over \$200M of transactions with partners from 2016 – 2021 and co-founded the #4 Fastest Growing Company on the Inc5000, Revolutionary Clinics before departing in 2022 to focus on new ventures.

Ryan was enlightened early by "ugly business roll-ups", realizing consistent returns by combining businesses, standardizing logistics, and maintaining a Customer First mentality. Taking a page from an investment thesis within the Ansin family, Ryan has begun investing time and resources into waste-tovalue platform companies.

Early in his career, Ansin cofounded Clarity Project - an ethical diamond mining project in Sierra Leone, EPHAS - a photojournalism education nonprofit across 13 countries, has been an active early-stage investor since 2012 and was President of Family Office Association from 2012 - 2015. Ansin is often requested to share his experience and vision globally at events such as: World Economic Forum, Renaissance Weekend, FOA, ArcView, GreenTable, CannaBrunch, Forbes, and other assemblies alobally.

MaryAnne previously served as President and CEO of Forest City Ratner Companies, where she oversaw a period of game-changing ground-up development and managed its multimillion square foot residential, commercial and retail portfolio.
